EATONIA WASTE DISPOSAL GROUNDS**



The Council of the Town of Eatonia in the Province of Saskatchewan, enacts as follows:

1. The Town of Eatonia is hereby authorized to enter into an agreement with the council of the R.M. of Chesterfield No. 261. The terms of which are attached hereto and marked Exhibit "A".
2. The mayor and administrator of the Town of Eatonia, are hereby authorized to sign and execute an agreement, the terms of which are set out in Exhibit "A" heretofore referred to.

## PARTNERSHIP AGREEMENT

This Partnership Agreement made this 13 day of December, 2016 between the

**TOWN OF EATONIA**

and

**R.M. OF CHESTERFIELD NO. 261**

This agreement sets forth the terms of understanding between the Town of Eatonia and the R.M. of Chesterfield No. 261.

**1. Purpose**

To operate and maintain the Eatonia Waste Disposal Grounds located at the south end of quarter section NW-26-25-25-W3rd.

**2. Effective Time Frame**

The term shall be effective from the 1<sup>st</sup> day of January, 2017 and shall continue until terminated in writing by either municipal council.

**3. Funding**


Each municipality will pay for the following:


PARTNER	DESCRIPTION
Town of Eatonia	<ul style="list-style-type: none"><li>➤ Provide cell phone for custodian to use and pay for monthly cell phone plan</li><li>➤ Pay for propane to heat the nuisance grounds shack</li><li>➤ Pay for the fuel for the lawn mower and fire starter for the wood pile</li></ul>
R.M of Chesterfield No. 261	<ul style="list-style-type: none"><li>➤ Pay the wages of the Pest Control Officer and poison to control rats at the nuisance grounds</li><li>➤ Maintain the road into the nuisance grounds</li></ul>
Town of Eatonia & R.M. of Chesterfield Shared	<ul style="list-style-type: none"><li>➤ Custodian contract wages</li><li>➤ Repairs to the nuisance grounds shack and fence</li><li>➤ Unforeseen repairs to the pay loader while cleaning up at the nuisance grounds</li><li>➤ Cost of the custom work to clean up at the nuisance grounds</li></ul>

**4. Evaluation**

Both municipalities shall review this agreement on an annual basis.


