## BYLAW NO. 41 A

A bylaw to restrict the parking of equipment containing lethal insecticides, and to restrict the use of high volatility weed sprays.

THE COUNCIL OF THE TOWN OF EATONIA, IN COUNCIL ASSEMBLED, ENACTS AS FOLLOWS:

- I. No person shall park or leave any vehicle or any other equipment which is used for the application of any lethal insecticide upon any public roadway or in any other public place within the Town of Eatonia.
- 2. No person shall place or leave any unsealed container containing lethal insecticide or solution thereof upon any public roadway or in any public place within the Town of Eatonia.
- 3. No person shall use any lethal insecticide or have any equipment for the use thereof in any place other than a public roadway or other public place within the town, UNLESS SUCH PERSON SHALL EXERCISE ALL NECESSARY PRECAUTIONS TO PREVENT INJURY TO PERSONS AND TO ANIMALS.
- 4. No person shall park any vehicle or any other equipment or leave any unsealed container containing any high volatility weed spray or solution thereof in any public roadway or in any public place within the Town of Eatonia.
- 5. No person shall use or cause to be used any high volatility weed spray within the limits of the Town of Fatonia in such manner as to cause damage to trees, shrubs, hedges or gardens.
- 6. Any police officer or any other duly authorized officer of the town may cause the removal from the town, or to some secure place within the town, of any vehicle, equipment or container found within the town in contravention of the provisions of this bylaw.
- 7. Any person found to be guilty of any infraction of this bylaw shall be liable to the penalty provided by the General Penalty Bylaw of the Town of Eatonia.
- 8. No provision of this bylaw shall apply to any employee of the town proceeding with due caution upon the exercise of his duty as lawfully directed by the Council.
- 9. Bylaw No. 4I is hereby repealed.

## Bylaw No. 41 A

A bylaw to restrict the parking of equipment containing lethal insecticides, and to restrict the use of high volatility weed sprays.

- 2. No person shall place or leave any unsealed container containing lethal insecticted or solution thereof upon any public roadway or in any public place within the Town of Eatonia.
- 3. No person shall use any lethal insecticide or have any equipment for the use thereof in any place other than a public roadway or other public place within the town, UNLESS SUCH PERSON SHALL EXERCISE ALL NEGESSARY PRECAUTIONS TO PREVENT INJURY TO PERSONS AND TO ANIMALS.
- 4. No. person shall park any vehicle or any other equipment or leave any unsealed container containing any figh volatility weed spray or solution thereof in any public roadway or in any public place within the Town of Eatonia.
- 5. No person shall use or cause to be used any high volatility weed spray within the limits of the Town of Eatonia in such manner as to cause damage to trees, shrubx, hedges or gardens.
- 6. Any police officer or any other duly authorized officer of the town may cause the removal from the town, or to some secure place within the town, of any vehicle, equipment or container found within the town in contravention of the provisions of this bylaw.
- 7. Any person found to be guilty of any infraction of this bylaw shall be liable to the penalty provided by the General Penalty Bylaw of the Town of Eatonia.
- 8. No provision of this bylaw shall applay to any employee of the town prodeeding with due caution upon the exercise of his duty as lawfully directed by the Council.
- 9. Bylaw No. 41 is hereby repealed.
- 10. This bylaw shall come into force and effect on the day of final passage thereof.
