BYLAW NO. 7/15

A BYLAW TO PROVIDE FOR PUBLIC DISCLOSURE BY MEMBERS OF COUNCIL

The Council of the Town of Eatonia, in the Province of Saskatchewan, enacts as follows:

- 1. This Bylaw shall be referred to as the "Public Disclosure Bylaw".
- 2. The purpose of this bylaw is to avoid conflict of interest and to add transparency to the municipal process.
- 3. Pursuant to Section 142 of *The Municipalities Act*, every member of council must file a Public Disclosure Statement, Form 1 attached hereto and forming part of this bylaw, with the Administrator within thirty days of being elected.
- 4. Every member of Council who has previously filed a Public Disclosure Statement must annually submit a Public Disclosure Annual Declaration, Form 2 attached hereto and forming part of this bylaw, that either declares that no change in any information has occurred or details the change in the information that has occurred since the last Public Disclosure Statement was filed.
- 5. The annual declaration as outlined in Section 4 of this Bylaw must be submitted on or before November 30th in each year.
- 6. If there is a change in any information contained in a member of Council's Public Disclosure Statement filed pursuant to section 3, within 30 days after the change, the member of council must notify the Administrator and file a Public Disclosure Statement Amendment, Form 3 attached hereto and forming a part of this bylaw, with the Administrator that details the change in the information that has occurred since the last Public Disclosure Statement was filed.
- 7. The Administrator shall ensure that each Public Disclosure Statement and Declaration is available for public inspection during normal business hours.
- 8. This Bylaw shall come into force and take effect upon third reading thereof.
