BYLAW #14/82

A bylaw to regulate plumbing and the disposal of sewage.

The Council of the Town of Eatonia enacts as follows:

- (a) The regulations of the Department of Public Health of the Province of Saskatchewan shall apply to all plumbing and sanitary sewer drainage within the Town of Eatonia, except as herein altered or added to.
 - (b) Notwithstanding any regulation of the Department of Public Health of the Province of Saskatchewan, it shall be lawful within the town to use plastic waste pipe and fittings in place of metal pipe and fittings, EXCEPTING with respect to any building where the construction specifications, as approved by the Department of Public Health and/or where appropriate, by the office of the Fire Commissioner, direct otherwise.
- 2. Application for a plumbing permit shall be made by the plumbing contractor on a prescribed form, and shall be accompanied by the required fee, to the Town Clerk or the Plumbing Inspector.
- 3. The fee for a plumbing permit shall be as follows:
 - (a) ten dollars (\$10.00) for or up to the first ten fixtures to be installed, and one dollar (\$1.00) for each additional fixture; for the purpose of this section, fixtures shall not include floor drains, hot water tanks, softeners or other similar appurtenances.
 - (b) five dollars (\$5.00) for any installations or alteration where not more than two fixtures or devices are to be erected or installed.
 - (c) five dollars (\$5.00) for the installation of a private sewage works, and
 - (d) five dollars (\$5.00) for a permanent connection of an existing plumbing system to a sewage works and/or waterworks.
- 4. All persons undertaking the installation or repair of plumbing shall be in possession of a certificate of qualification issued by the Province of Saskatchewan.
- 5. Any person guilty of an infraction of the provisions of this bylaw, in respect to which no penalty is provided by the Public Health Act of the Province of Saskatchewan, shall be liable to the penalties provided by the General Penalty Bylaw of the Town of Eatonia.
- 6. Bylaw No. 10, Bylaw No. 12 and Bylaw No. 13/82 are hereby repealed.
