

**TOWN OF EATONIA**

**BYLAW NO. 6/10**

**A BYLAW TO RESTRICT THE USE AND CONSUMPTION  
OF WATER IN THE TOWN OF EATONIA**

---

The Council of the Town of Eatonia in the Province of Saskatchewan enacts as follows:

**SECTION I - SHORT TITLE, APPLICATION AND INTERPRETATION:**

**Short Title:**

1. This Bylaw may be cited as "The Water Restriction Bylaw".

**Application:**

2. All of the provisions and enactments set forth in this Bylaw relate to and will be in full force and effect within the limits of the Town of Eatonia.

**Interpretation:**

3. In this Bylaw, unless the context otherwise requires, the expression(s):
  - a) "**Administrator**" shall mean the Town Administrator of the Town of Eatonia.
  - b) "**Bylaw Enforcement Officer**" shall mean the Bylaw Enforcement Officer appointed or Council designated for the Town of Eatonia.
  - c) "**Council**" shall mean the Council of the Town of Eatonia.
  - d) "**Person**" shall mean a corporation or partnership as well as a man, woman or child.
  - e) "**Town**" shall mean the Town of Eatonia, in the Province of Saskatchewan.

**1) Definition:**

Other words and expressions used in this Bylaw shall have the same meaning as given to them in Act.

**2) Gender:**

Except where the context other wise required, all references in the masculine gender shall also be deemed to include the feminine gender.

**3) Validity:**

If any section, clause or provisions of this Bylaw is for any reason declared by a court of competent jurisdiction to be valid, the same shall not affect the validity of the Bylaw as a whole or any part thereof, other that the section, clause, or provisions so declared to be valid.

**SECTION II - GENERAL PROHIBITIONS:**

1. Hours for outside watering shall be 7:00 to 10:00 morning and evening.
2. Odd numbered addresses shall be allowed to use water for outdoor purposes on odd numbered calendar days.
3. Even numbered address shall be allowed to use water for outdoor purposes on even numbered calendar days.
4. Water restrictions shall apply to anyone reseeding an existing lawn.
5. Water restrictions shall be in effect January to December of each year.

6. The Mayor or any member of Council may further restrict the use of water in emergencies such as fire or other emergency where abnormal amounts of water are required.
7. Watering permits, as per Schedule "A", will be issued for anyone planting a new lawn.

**SECTION III - PENALTIES:**

1. First infraction of the provisions of this Bylaw shall be subject to a fine of one hundred dollars (\$100.00).
2. Second and subsequent infraction of the provisions of this Bylaw shall be subject to a fine of two hundred and fifty dollars (\$250.00).

**Cancellation of Tickets:**

3. The issuing Peace Officer or Bylaw Enforcement Officer may cancel any Notice of Violation where, in the opinion of the issued Peace Officer or Bylaw Enforcement Officer, that Notice of Violation was issued improperly or in error.

**SECTION IV - EFFECTIVE DATE:**

1. This Bylaw shall come into force and be in effect on the final passing thereof.
