### Written Report:

9/4/19 Somerville/Scott That the following written report from Foreman Rob Assmus be received as information:

- Water plant test results were good. Currently they are running off the infield well.
- Currently they are having issues with one of the VFD's at the water treatment plant. They had sent away VFD #2 to be repaired for \$315.00 and it came back repaired but that wasn't the problem. They had Carbon Controls out for 7 hours at no charge to try to repair VFD #1 with no luck. They found out the problem is with the communication between the two VFD's. They replaced most of the parts in VFD #1, so it has to be sent back to Calgary with the potential cost of around \$1000.00 or it can just be replaced with a new identical model for \$1,880.00 plus applicable taxes. Rob recommends to buy a new
- Spent a lot of the month dealing with frozen water and sewer lines. Houses with frozen lines were hooked up to the neighbour's houses so no one was without water. Two of the water lines were thawed out but one is still frozen. Rob is hoping to thaw it out by end of the week. Waiting to see if any more freeze.
- Did have some turbidity issues at the wells. Power was flickering causing the CN Crib pump to jump and agitate the water causing extremely high turbidity levels. Reported to EPO and shut off CN Crib and went to well #1 and continually flushed system. The CN Crib was repaired with
- Repaired head stones and did leveling out at the cemetery and a couple of burials.
- The Chameleon tractor was sent back after it was demoed here. .
- On Saturday, April 6th trailer on 1st Avenue East water line froze which then broke and flooded the neighbour's basement. Curb stop didn't hold so had to go in to house when no one was home and shut off in the basement. Tried contacting the homeowner but there was no answer.
