SPECIAL MEETING MINUTES
TUESDAY, FEBRUARY 15, 2022**

Minutes of the special meeting of the Council of the Town of Eatonia held the 15th day of February 2022 in the Town Council Chambers at 202 Main Street, Eatonia, Saskatchewan.

PUBLIC NOTICE:

CALL TO ORDER:

A quorum being present, Mayor Scott called the meeting to order at 6:00 p.m.

AGENDA:

A special meeting was called to discuss the following matters:

1. Tax Title Property Building (old service station) at 109 Railway Avenue East

The last winter storm that we had on January 31, 2022 damaged the roof on a garage (tax title property) that the Town of Eatonia owns.

The Town Council met to discuss whether to repair or demolish the building.

Mike Craney and Clifford Brummund attended the meeting. They are currently renting the building from the town on a monthly basis. They drafted a proposal to help with the cost of repairs to the roof. They will contribute \$10,000 each towards the repairs. This payment will then be deducted from their monthly rent of \$250.00 each until the payment is paid in full which will be approximately 40 months or 3 1/3 years.






